THIS AGREEMENT made in duplicate this 12th day of January, A. D. 1959.

B E T W E E N:

WATERLOO COLLEGE ASSOCIATE FACULTIES, a corporation incorporated under the laws of the Province of Ontario, having its head office at the City of Waterloo, in the Province of Ontario,

OF THE FIRST PART:

and

EVANGELICAL LUTHERAN SEMINARY OF CANADA, on behalf of Waterloo College, a corporation incorporated by private Act of the Legislature of the Province of Ontario, having its head office at the City of Waterloo in the Province of Ontario,

OF THE SECOND PART:

and

ST. JEROME'S COLLEGE, a corporation incorporated by private Act of the Province of Ontario, having its head office in the City of Kitchener, in the Province of Ontario,

OF THE THIRD PART:

WHEREAS Waterloo College Associate Faculties is about to apply to the Legislative Assembly of the Province of Ontario for university status under the name of The University of Waterloo,

AND WHEREAS the said Waterloo College Associate Faculties has entered into agreements with the parties of the second and third parts whereby the parties of the second and third parts are to become federated with the said University of Waterloo which such agreements do not come into full force until the passage of the private Bill forming The University of Waterloo,

AND WHEREAS it is within the contemplation of the parties hereto that other colleges may apply to be federated or affiliated with The University of Waterloo,

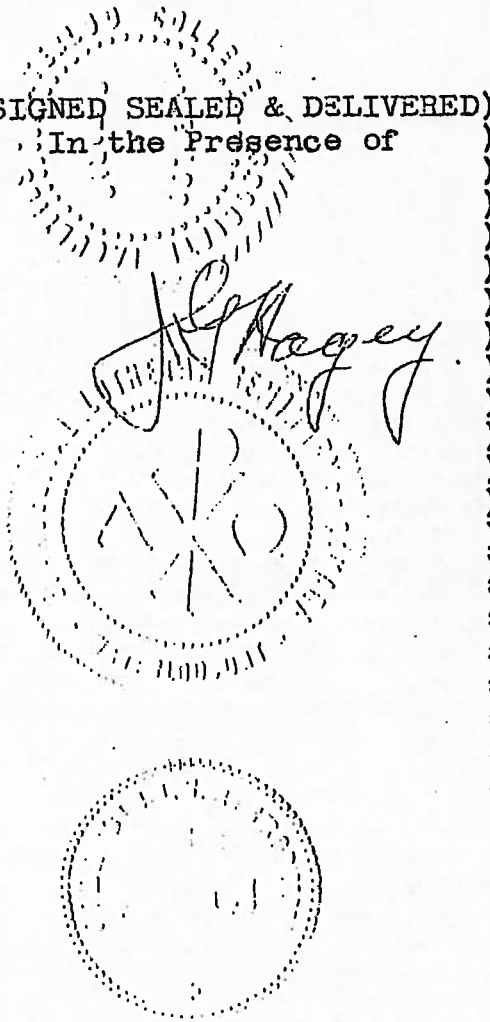
NOW IT IS AGREED by and between the parties hereto that in the event of any college or colleges other than the parties hereto of the second and third parts applying to The University of Waterloo either before or after the passage of its university

Bill for federation or affiliation with The University of Waterloo, such federation or affiliation will not be accepted by The University of Waterloo without the written approval of the Boards of Governors of the parties of the second and third parts, but such written approval shall not be unreasonably withheld.

This Agreement shall be binding upon and shall enure to the benefit of the parties hereto and their successors by any other name.
